## CONDITIONS

Serviced By: The Meadowlands  
Sponsored By: The Meadowlands, et al.

**Cancellation:** The Sponsors reserve the right to cancel any or all of the races if it becomes impractical or undesirable in the opinion of The Sponsors to conduct said races. If an event is not raced, The Sponsors responsibility and liability shall be limited to refunding, without interest, all payments collected toward these events. These monies will be pro-rated among those owners of horses eligible at the time of cancellation.

**Added Money:** Meadowlands will add \$30,000 to both events. These funds, barring any unforeseen circumstance which may preclude this, in addition to all monies paid in by nominating horsemen shall constitute the purses for these events.  
**Payments (US Funds only):** A nomination to each event requires all payments be made as advertised. All payments are forfeits.

**Declaration:** Declarations for these events will close at the time and date designated on the condition sheet. There are no refunds for scratched horses. At the time of declaration, horses declared to race in these events must have a clean charted past performance line that meets The Meadowlands qualifying standards. A horse that starts in a leg of an event shall remain qualified for that event until its conclusion.

**Notice:** USTA Rule 11 Sec 3 provides: "Failure to make any payment required by the conditions constitutes an automatic withdrawal from the event."

**Racing Conditions:** Legs to be raced at one mile with the exception that field size requiring one or more trailers in any leg will be raced at 1 and 1/8 miles. The Meadowlands may require a minimum number of betting interests to declare in any event (leg or final) or the event may be cancelled. If more than twelve (12) horses declare to start in a leg, the race shall be raced in divisions. The final shall be limited to the top ten (10) money winning horses from the preliminary legs. If two (2) or more horses are tied for 10th place, starters shall be drawn by lot by the Judges. In the event one of the highest money earners fails to declare, the next highest money winner to declare shall be eligible for the final. If enough money earners fail to declare for the final, starters in the series that

are not money earners may declare for the finals and such entries shall be drawn. Two (2) also eligibles may be selected from the next two highest money earners that declare. Horses must start in at least one (1) leg to be eligible for the final. The sponsors reserve the right to reject any entry and return the fees paid toward that entry. All starters are subject to the detention policy of The Meadowlands.

**Money Division:**  
50%, 25%, 12%, 8% & 5% or USTA standard for less than five places for all races.

**Disputes:** All owners, trainers and drivers of horses nominated to this event must be accepted to participate at each Host Track or the nomination/entry may be denied without refund of previous payments. Any change of trainers made fewer than 30 days or within four starts of the date of this race will be reviewed by the sponsor. If such change is not accepted, it may result in refusal of entry. Sponsors reserve the right to amend these conditions as deemed necessary without liability.

**Rules:** A minimum of seven (7) separate interests may be required in any event or the event may be cancelled. All starters are subject to the detention policy of the Host Track. The rules of the Host Track and its state Racing Commission along with the USTA shall govern unless otherwise specified in these conditions. These races are subject to the Stallion Restriction Rule (see Meadowlands website for details). A nomination to these events is an agreement to the above terms and conditions.
